- 5. Outline indications and applications of color Doppler in the emergency and critical care setting.
- 6. Perform ultrasound evaluation of the lung, ocular, soft-tissue, musculoskeletal and bony cortices in the emergency department.
- 7. Demonstrate the use of ultrasound guidance for peripheral vascular access.
- 8. Recognize the sonographic appearance of individual nerves and list the advantages.
- 9. Perform ultrasound evaluation of the acute scrotum.
- 10. Identify potential triggers of heart failure.
- 11. Evaluate and assess heart failure through echocardiography.
- 12. Outline the training requirements and indications for transesophageal echocardiography.
